WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, Sir CRR College of Education, Opp. to S.P. Bungalow, N.H. 5, Eluru-534007, West Godavari District, Andhra Pradesh vide order No. F.AP/B.Ed/21/SRO/NCTE/2000-01/1275 dated 19.07.2000 for conducting Secondary (B.Ed.) Course of one year duration with an annual intake of 75 students and F.SRO/NCTE/2001-2002/7898 dated 18.09.2001 for an intake of 160 students.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution 2. had consented to come under new Regulations vide a notarized affidavit dated 31.01.2015. A revised provisional recognition order was issued on 06.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 150 students (three basic units) from the academic session 2015-16.
- AND WHEREAS, on the basis of request, the SRC in its 342nd meeting held on 5th - 6th July, 2017 decided for reduction of intake from 3 units to 1 unit. Accordingly, a order was issued to the institution for reduction of intake from 3 units to 1 unit on dated 08.08.2017.
- AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 decided that the Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on 13.05.2019. The institution has submitted reply dated 14.06.2019.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice issued to the institution on 08.11.2019.
- AND WHEREAS, the SRC in its 394th meeting held on 27th -28th January 2021 considered the matter and decided to issue last reminder letter. Accordingly, as per decision of SRC a last reminder letter was issued to the institution on 15.03.2021. The institution has not submitted reply to the last reminder letter.
- AND WHEREAS, the SRC in its 412th meeting held on 05th 06th July 2022 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC withdrawal order no. F.SRC/NCTE/APS00425/B.Ed/AP/2022/132608-132612 dated 20.07.2022 was issued to the institution.
- AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P (C) No.14076/2022 & CM APPLs. 42987/2022 titled as Sir CRR College of Education versus National Council for Teacher Education & Anr. Whereby the Hon'ble High Court in its order dated 28.09.2022 has directed that:

"The NCTE is directed to reflect the status of the Petitioner as a recognized institution for the year 2022-23 on its website. The NCTE is also directed to communicate the same to the Petitioner's affiliating university and the concerned State Government within one week from today.

The Appellate Committee of the NCTE shall endeavour to dispose of the Petitioner's appeal as expeditiously as possible and practical, and not latter than three months from today."

- 9. AND WHEREAS, the SRC in its 415th meeting held on 03rd 04th November, 2022 has considered the matter and decided to issue letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 17.11.2022.
- 10. AND WHEREAS, aggrieved by the order dated 20.07.2022 of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-225/E-269145/2022/Appeal/8th Meeting, 2022 APPLSRC202214448 dated 16.11.2022 appeal remand back the order appealed against. The institution vide letter dated 21.11.2022 submitted reply to the appeal remand back order.
- 11. AND WHEREAS, the SRC in its 417th Meeting held on 01st 02nd December, 2022 considered the matter and decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sir CRR College of Education, Survey No. 104/1, 104/2, 104/3, GNT Road, Eluru-534007, West Godavari District, Andhra Pradesh for B.Ed. programme for 1 basic unit of 50 students.

The Committee further decided that the above said decision will be subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR).

- 12. NOW THEREFORE, this order is issued permitting the institution i.e., Sir CRR College of Education, Survey No. 104/1, 104/2, 104/3, GNT Road, Eluru-534007, West Godavari District, Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR), and fulfilment of the following conditions:-
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the 111. examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff duly IV. approved by affiliating body for conducting the course should always remain in position.

- Further, the institution is required to fulfil all such other requirements as may be 13. prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee as Self Appraisal Report 14. at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain its Website with hyperlink to the Council and the 15. Southern Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
 - Sanctioned programme(s) along with annual intake in the institution: a.
 - Name of faculty and staff in full as mentioned in school certificate along with b. their qualifications, scale of pay and photograph.
